

Demographic Profile

The population in Perry County, Pennsylvania was 45,647 per American Community Survey data for 2012-2016.

The region has a civilian labor force of 24,260 with a participation rate of 65.9%. Of individuals 25 to 64 in Perry County, Pennsylvania, 17.8% have a bachelor's degree or higher which compares with 31.8% in the nation.

The median household income in Perry County, Pennsylvania is \$58,585 and the median house value is \$161,800.



Employment Trends


As of 2017Q3, total employment for Perry County, Pennsylvania was 9,632 (based on a four-quarter moving average). Over the year ending 2017Q3, employment increased 0.1% in the region.



Employment data are derived from the Quarterly Census of Employment and Wages, provided by the Bureau of Labor Statistics and imputed where necessary. Data are updated through 2017Q1 with preliminary estimates updated to 2017Q3.

Unemployment Rate


The seasonally adjusted unemployment rate for Perry County, Pennsylvania was 4.2% as of November 2017. The regional unemployment rate was lower than the national rate of 4.3%. One year earlier, in November 2016, the unemployment rate in Perry County, Pennsylvania was 4.6%.

Wage Trends

The average worker in Perry County, Pennsylvania earned annual wages of \$33,452 as of 2017Q3. Average annual wages per worker increased 1.8% in the region during the preceding four quarters. For comparison purposes, annual average wages were \$54,666 in the nation as of 2017Q3.



Annual average wages per worker data are derived from the Quarterly Census of Employment and Wages, provided by the Bureau of Labor Statistics and imputed where necessary. Data are updated through 2017Q1 with preliminary estimates updated to 2017Q3.

Cost of Living Index

The Cost of Living Index estimates the relative price levels for consumer goods and services. When applied to wages and salaries, the result is a measure of relative purchasing power. The cost of living is 1.8% lower in Perry County, Pennsylvania than the U.S. average.



Industry Snapshot

The largest sector in Perry County, Pennsylvania is Retail Trade, employing 1,364 workers. The next-largest sectors in the region are Transportation and Warehousing (1,242 workers) and Health Care and Social Assistance (1,094). High location quotients (LQs) indicate sectors in which a region has high concentrations of employment compared to the national average. The sectors with the largest LQs in the region are Agriculture, Forestry, Fishing and Hunting (LQ = 4.37), Transportation and Warehousing (3.09), and Construction (1.93).

Employment data are derived from the Quarterly Census of Employment and Wages, provided by the Bureau of Labor Statistics and imputed where necessary. Data are updated through 2017Q1 with preliminary estimates updated to 2017Q3.

Sectors in Perry County, Pennsylvania with the highest average wages per worker are Management of Companies and Enterprises (\$63,183), Finance and Insurance (\$50,720), and Manufacturing (\$46,323). Regional sectors with the best job growth (or most moderate job losses) over the last 5 years are Accommodation and Food Services (+146 jobs), Transportation and Warehousing (+121), and Construction (+36).

Over the next 1 year, employment in Perry County, Pennsylvania is projected to contract by 10 jobs. The fastest growing sector in the region is expected to be Health Care and Social Assistance with a +1.5% year-over-year rate of growth. The strongest forecast by number of jobs over this period is expected for Health Care and Social Assistance (+16 jobs), Construction (+3), and Professional, Scientific, and Technical Services (+1).

Occupation Snapshot

The largest major occupation group in Perry County, Pennsylvania is Transportation and Material Moving Occupations, employing 1,274 workers. The next-largest occupation groups in the region are Office and Administrative Support Occupations (1,152 workers) and Sales and Related Occupations (944). High location quotients (LQs) indicate occupation groups in which a region has high concentrations of employment compared to the national average. The major groups with the largest LQs in the region are Farming, Fishing, and Forestry Occupations (LQ = 2.25), Transportation and Material Moving Occupations (1.95), and Construction and Extraction Occupations (1.82).

Occupation groups in Perry County, Pennsylvania with the highest average wages per worker are Management Occupations (\$89,800), Legal Occupations (\$89,800), and Computer and Mathematical Occupations (\$64,900). The unemployment rate in the region varied among the major groups from 1.5% among Legal Occupations to 6.2% among Food Preparation and Serving Related Occupations.

Over the next 1 year, the fastest growing occupation group in Perry County, Pennsylvania is expected to be Personal Care and Service Occupations with a +1.4% year-over-year rate of growth. The strongest forecast by number of jobs over this period is expected for Personal Care and Service Occupations (+5 jobs) and Community and Social Service Occupations (+3). Over the same period, the highest separation demand (occupation demand due to retirements and workers moving from one occupation to another) is expected in Transportation and Material Moving Occupations (146 jobs) and Sales and Related Occupations (133).



Industry Clusters


A cluster is a geographic concentration of interrelated industries or occupations. The industry cluster in Perry County, Pennsylvania with the highest relative concentration is Agricultural with a location quotient of 4.14. This cluster employs 587 workers in the region with an average wage of \$29,621. Employment in the Agricultural cluster is projected to contract in the region about 0.9% per year over the next ten years.

Education Levels


Expected growth rates for occupations vary by the education and training required. While all employment in Perry County, Pennsylvania is projected to contract 0.1% over the next ten years, occupations typically requiring a postgraduate degree are expected to grow 0.9% per year, those requiring a bachelor's degree are forecast to grow 0.3% per year, and occupations typically needing a 2-year degree or certificate are expected to grow 0.3% per year.


Gross Domestic Product

Gross Domestic Product (GDP) is the total value of goods and services produced by a region. In 2016, nominal GDP in Perry County, Pennsylvania expanded 3.0%. This follows growth of 3.5% in 2015. As of 2016, total GDP in Perry County, Pennsylvania was \$707,094,000.



Gross Domestic Product data are provided by the Bureau of Economic Analysis, imputed by Chmura where necessary, updated through 2016.

Of the sectors in Perry County, Pennsylvania, Construction contributed the largest portion of GDP in 2016, \$87,931,000 The next-largest contributions came from Educational Services (\$86,081,000); Real Estate and Rental and Leasing (\$76,588,000); and Transportation and Warehousing (\$71,441,000).

FAQ

What is a location quotient?

A location quotient (LQ) is a measurement of concentration in comparison to the nation. An LQ of 1.00 indicates a region has the same concentration of an industry (or occupation) as the nation. An LQ of 2.00 would mean the region has twice the expected employment compared to the nation and an LQ of 0.50 would mean the region has half the expected employment in comparison to the nation.

What is separation demand?

Separation demand is the number of jobs required due to separations—labor force exits (including retirements) and turnover resulting from workers moving from one occupation into another. Note that separation demand does not include all turnover—it does not include when workers stay in the same occupation but switch employers. The total projected demand for an occupation is the sum of the separation demand and the growth demand (which is the increase or decrease of jobs in an occupation expected due to expansion or contraction of the overall number of jobs in that occupation).

What is a cluster?

A cluster is a geographic concentration of interrelated industries or occupations. If a regional cluster has a location quotient of 1.25 or greater, the region is considered to possess a *competitive advantage* in that cluster.

What is the difference between industry wages and occupation wages?

Industry wages and occupation wages are estimated via separate data sets, often the time periods being reported do not align, and wages are defined slightly differently in the two systems (for example, certain bonuses are included in the industry wages but not the occupation wages). It is therefore common that estimates of the average industry wages and average occupation wages in a region do not match exactly.

What is NAICS?

The North American Industry Classification System (NAICS) is used to classify business establishments according to the type of economic activity. The NAICS Code comprises six levels, from the "all industry" level to the 6-digit level. The first two digits define the top level category, known as the "sector," which is the level examined in this report.

What is SOC?

The Standard Occupational Classification system (SOC) is used to classify workers into occupational categories. All workers are classified into one of over 820 occupations according to their occupational definition. To facilitate classification, occupations are combined to form 23 major groups, 96 minor groups, and 449 occupation groups. Each occupation group includes detailed occupations requiring similar job duties, skills, education, or experience.
